Who is The Others Online?

How did we obtain your personal data?

The Others Online has obtained your data because you have provided this data to us. .

What are your rights?

Under the European General Data Protection Regulation you have a number of rights with

regard to your data and the processing thereof:

Access

You may access your personal information and make any necessary changes in your account. If you would like to see which personal data The Others Online has obtained about you, you may exercise your right of access by submitting a request to The Others Online.

Making changes

If you wish to make changes to the personal information that you have seen as a result of a request for access and you are unable to make the changes yourself in your account, you may request that The Others Online makes these changes for you. You may request that The Others Online modifies, corrects, supplements, erases or shields your information.

Restriction of processing of personal data

You also have the right, under certain conditions, to ask The Others Online to restrict the processing of your personal data.

Right to object

If processing of your data takes place on the grounds of 'legitimate interest' by The Others Online or a third party, you have the right to object to that processing.

Portability of data

You have the right to obtain your personal data from The Others Online. The Others Online will provide this in a structured and commonly used format, which can easily be opened using commonly used digital systems.

Withdrawing consent

When the legal basis for a particular processing is your explicit consent, you have the right to withdraw that consent. This does not affect past processing, but does mean that we will no longer be allowed to process this data in the future. It may also result in The Others Online no longer being able to provide you with certain services.

Response from The Others Online

A request can be sent to online@the-others.eu. The Others Online will comply with your request as soon as possible and in any case no later than one (1) month after The Others Online has received such a request. If The Others Online rejects your request, we will indicate in our reply why the request was rejected.

Recipients of your personal data

It is possible that The Others Online is required to submit your data to a third party, for example to fulfil a legal obligation.

What are cookies and how does The Others Online use them?

Cookies are small pieces of (text) information that are sent to your browser when you visit the website of The Others Online and then stored on the hard disk or in the memory of your device. The cookies placed via The Others Online's website cannot damage your device or the files stored on it. With 'cookies', we also mean comparable techniques collecting information, such as device fingerprinting.
